**Subject: INDUSTRIAL EFFLUENT DISCHARGE PERMIT**  
**ERF NO: N26 000 00001642 00002**

Your Industrial Effluent Discharge Permit Application Form, dated 14/11/2016 refers.

In terms of powers delegated to the Head of Department, Water Services, by the Ekurhuleni Metropolitan Municipality, permission is hereby granted to the above mentioned company to discharge industrial effluent, as described, into the Municipality's sewer system. This discharge shall take place in accordance with the requirements of the Ekurhuleni Metropolitan Municipality Waste Water By-laws and tariff structure.

**This permission shall be revocable by the Ekurhuleni Metropolitan Municipality at any time, at its absolute discretion. Reasonable notice of such action will be given to the applicant in writing.**

Said permission is granted subject to the following conditions:

1. The effluent must at all times comply with the standards as laid down in the Ekurhuleni Metropolitan Municipality Waste Water By-laws and tariff structure.
2. No storm water pollution should occur.
3. No storm- or rain water should be allowed to enter the Municipality's sewer system.
4. Toxic solid waste must be disposed of legally and proof of such disposal must be readily available for inspection by the investigation officer of the Ekurhuleni Metropolitan Municipality.
5. An accessible sampling point must be provided.
6. Water Balances must be done regularly to evaluate industrial effluent discharge volumes.
7. The industrial effluent tariff will be calculated on the effluent meter readings and all possible measures should be taken to ensure that the meter is functioning properly.
8. The Industrial effluent tariff will be calculated on 100 % of the water consumed on site, in the event of unforeseen effluent meter failure
9. The permit will be valid for two years from the date indicated on the permit.
